The Powers and functions of the Joint Programme Committee would be follows:-

1. Regular review of the work of the Execution Support agencies until Project completion.
2. Taking decision on coordination issues to facilitate removal of bottlenecks that may arise in the project implementation by execution support agencies.
3. Approval of Terms of references of consultants for services involving more than an agency.

The Project Director of KLGSDP who is the Convener of the Joint Programme Committee will discharge the following functions:-

1. Convene regular meetings of the Committee in consultation with the Chairman.
2. Prepare the minutes of the meeting and circulate it to the members after approval of the Chairman.
3. Ensure compliance of all decisions of the Committee.

General

1. The Administrative Department for the above Committee will be the Local Self Government Department.
2. The tenure of the Committee shall extend till Project completion.
3. The Committee shall meet at least once in a fortnight/month or more frequently if necessary.
4. The quorum of the Committee would be at least four regular members including the project director and the representatives of execution support agencies and special invitees relating to the subject in the agenda.
