- 5) Take other decisions as may be required to ensure effective decentralization.

This committee is empowered to take decisions on various issues related to decentralization and people's planning campaign except those matters which require the approval of the Council of Ministers.

The committee will meet on a fixed date and time every month. The Secretary Local Self Government Department, being the Member Secretary & Convener should convene the meeting of the committee every 2nd week without fail.


