### ORDER

Ministry of Panchayati Raj vide 1<sup>st</sup> paper read above empanelled TSIs (Technical Support Institutions) through open bids for preparation of perspective and Annual Plans for the Districts concerned under BRGF Programme for the 12<sup>th</sup> Five Year Plan period (2012-2017). The TSI's shortlisted for the state are the following :

1. Palakkad - Centre for Management Development (CMD), Thiruvananthapuram.
2. Wayanad - Maithri - NGO, Palakkad, Kerala.

The District Collector Palakkad have agreed to entrust Centre for Management Development, Thiruvananthapuram as the Technical Support Institution for 12<sup>th</sup> Plan period. The president District Panchayat Wayanad requested for entrusting the task of preparation of perspective plan and Annual Plan of Wayanad District to Centre for Management Development instead to the organisation short listed by Ministry of Panchayati Raj. On this Commissioner for Rural Development vide reference read above proposed sanction for the entrustment of the task of preparation of perspective and Annual Plans of Wayanad / Palakkad Districts to Centre for Management Development, Thiruvananthapuram, a time line for the activities related to the preparation of the said plans and the schedule of payments to the TSI. The High Power Committee in its meeting held on 25.08.2011 decided to entrust Centre for Management Development as TSI for both the districts and agreed with the above said proposals of the Commissioner for rural development.

In this circumstances Government are pleased to accord sanction for the following :

1. For the entrustment of the task of preparation of 6 years perspective plan (i) from 2011-12 to 2016 - 17 and Annual Plan 2012-13 of Palakkad / Wayanad District of BRGF to Centre for Management Development, Thiruvananthapuram.

2. For signing the MoU (Memorandum of Understanding Agreement) by the District Collector, Palakkad / Wayanad the Principal Secretary, Local Self Government Department (GOK) with the Centre for Management, Thiruvananthapuram in the format of the Draft MoU (dated: 06.06.2011) as in the website of the Ministry of Panchayati Raj excluding the provisions in the MoU regarding preparation of annual plan after 2012-13.
3. For the payment of Rs. 5.9 lakh to the CMD towards the fees for the preparation of perspective plan 2011-12 to 2016-17 and Annual Plan 2012-13 as per the payment schedule prescribed in the draft MoU as indicated below.
  1. Initial advance payment of Rs.2.5 lakh within 15 days of signing of the MoU.
  2. On preparation of perspective plan 2011-12 to 2016-17 and the first Annual Plan (2012-13) and entering on plan plus within 6 months of signing of MoU another Rs. 3.4 lakh would be paid.
4. For meeting the expenditure in this regard from the capacity building component of BRGF released by the Ministry of Panchayati Raj to Kerala Institute for Local Administration (KILA), Thrissur, Director KILA is directed to release the total amount required to be paid amounting to Rs. 5.90 lakh to the District Collector, Palakkad / Wayanad for making payment to CMD as per the approved payment schedule.
