ORDER

In the circumstances, Government are pleased to release an amount of Rs. Rs.140,00,00,000/- (Rupees one hundred and forty crore only) to various Municipalities and Grama Panchayats towards the World Bank aided Performance Grant under Kerala Local Government Service Delivery Project(KLGSDP) as per the details in Appendix IV to the Detailed Budget Estimate 2011-12. The transfer- credit is exempted from all Treasury restrictions.

The Director of Panchayats and Director of Urban Affairs Department will take immediate action for the institution-wise release of the fund to each Local body in conformity with the allocation made in Appendix IV

to the Detailed Budget Estimate 2011-12. The release of fund to the Seven Grama Panchayats - Munnar, Vattavada (Idukki), Triprangode (Malappuram) Mangalapady, Chemnad, Delampady and West Eleri (Kasaragod) and Thrikkakkara and Neeleswaram Municipalities will be made after obtaining the Clean Audit Certificate for 2008-09.


The controlling officers (Director of Panchayats, Director of Urban Affairs Department) will issue necessary orders indicating the institution -wise release of funds (net amount) and Letter of Authority (in form Annexure C-1) to the respective Local Self Government Institutions and to the Treasuries concerned for the release of World Bank Aided Performance Grant under Kerala Local Government Service Delivery Project (KLGSDP). In the case of Grama Panchayats, Deputy Director of the respective District will sign the letter of Authority to the Grama Panchayats under their Jurisdiction on the strength of the proceedings releasing the funds (indicating the amount released to each Grama Panchayat with District-wise total) issued by the Director of Panchayats.
