ORDER

In conformity with the orders in the G.O. read as 2nd paper above a total sum of Rs.55,70,270/- (27,85,135 X 2) has been deducted from the General Purpose Fund due to the Thiruvananthapuram Municipal Corporation for the months of April and May 2011 and transfer credited to the head of account 2515 - 00-901-99-01 towards salary of Engineering staff met from the Consolidated Fund. As per the reference read as 3rd paper above, the Secretary, Thiruvananthapuram Municipal Corporation has reported that the salary of Engineering staff of Local Self Government Department employed in Thiruvananthapuram Corporation for the months of April and May 2011 have been met from the own fund of the Corporation and not from the Consolidated Fund of the State. The Senior Deputy Director of Local Fund Audit Department, Thiruvananthapuram has also furnished a Certificate to this effect vide reference read as 4th paper above.

2. In the above circumstance, Government are pleased to accord sanction to restore an amount of Rs.55,70,270/- being the salary amount for the months of April and May 2011 already deducted from the monthly release of General Purpose Fund of the Thiruvananthapuram Municipal Corporation. Sanction is also accorded for transfer credit of **Rs.55,70,270/- (Rupees Fifty Five Lakh Seventy Thousand Two hundred and Seventy only)** by debit to the head of account 2515-00-800-77-34-Other Charges (N.P.) to the deposit account of Corporations MCFA-1 in the Public Account 8448-00-102-96(01) - Corporations and for the release of the same, vide Government Orders read as fifth and sixth.

3. Accordingly, sanction is accorded for the release of **Rs.55,70,270/- (Rupees Fifty Five Lakh Seventy Thousand Two hundred and Seventy only)** as detailed above to Thiruvananthapuram Municipal Corporation. The transfer credit is exempted from all Treasury restrictions.


