### **ORDER**

1. As per the Government Order read as 1<sup>st</sup> paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.

2. As per the Government Order read as 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> and 12<sup>th</sup> papers above sanction was accorded for the release of 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup> and 10<sup>th</sup> installments of Funds for Traditional Functions for the month of April, May, June, July, August, September, October, November, December and January 2012.

3. As per Government Order read as 13<sup>th</sup> paper above sanction was accorded for the drawal of total amount of **Rs.49,33,99,999/- (Rupees Forty Nine Crore Thirty Three lakh Ninety Nine thousand Nine hundred and Ninety Nine only)** from the budget provision under head of account 3604-00-200-93 (N.P.) being the 11<sup>th</sup> installment of Funds for Traditional Functions for the month of February 2012. Out of this, an amount of **Rs.2,64,65,374/- (Rupees Two Crore Sixty Four lakh Sixty Five thousand Three hundred and Seventy Four only)** is transfer credited to the major head of account 2515-other Rural Development Programme to adjust the salary cost (for February 2012) in respect of Engineering Cadre under Local Self Government Institutions as ordered in the Government Order read as 3<sup>rd</sup> paper above and **Rs. 46,69,34,625/- (Rupees Forty Six Crore Sixty Nine lakh Thirty Four thousand Six hundred and Twenty Five only)** was transfer credited to the Deposit Account of Local Self Government Institutions under State's Public Account being 11<sup>th</sup> installment of Funds for Traditional Functions for the month of February 2012.

4. Accordingly, sanction is accorded for the release of **Rs. 46,69,34,625/- (Rupees Forty Six Crore Sixty Nine lakh Thirty Four thousand Six hundred and Twenty Five only)** being the 11<sup>th</sup> installment of Funds for Traditional Functions for the month of February 2012 after adjusting the salary cost of Engineering cadre under Local Self Government Institutions.

5. The distribution of funds among the Local Self Government Institutions effected are as shown in the statement appended to Government Order read as 13<sup>th</sup> paper above. The amount so transfer credited is exempted from treasury restrictions.

6. The Controlling Officers will release the 11<sup>th</sup> installment to the Local Self Government Institutions concerned, being  $\frac{1}{12}$ <sup>th</sup> of the funds earmarked for Traditional Functions (after adjusting the salary cost of Engineering Wing), in accordance with the guidelines prescribed in Para 3 of the Government Order read as 1<sup>st</sup> paper above subject to the conditions laid down in the circular cited.



7. The progressive amount of release of fund to the Local Self Government Institutions for Traditional functions (General Purpose Fund) during 2011-12 including the release as per this order will be Rs.572,88,99,989/-

8. Accordingly Government are pleased to release the 11<sup>th</sup> installment of General Purpose Fund to District Panchayats and Corporations as follows.

In the case of Grama Panchayats, Deputy Director of Panchayats of the respective District will sign the Letter of Authority to the Grama Panchayats under their jurisdiction on the strength of the proceedings releasing the funds (specifying the amount released to each Grama Panchayat with District - wise total) to be issued by the Director of Panchayats.


