ORDER

The Ministry of Panchayati Raj, Government of India had released an amount of Rs. 17.86 crore to the State as Central Assistance under the Development Grant component of the Backward Regions Grant Fund (BRGF) to Wayanad for the implementation of the projects under the Special Component Plan for Scheduled Caste (SCPSC); Special Component plan for Scheduled Tribes Sub Plan (STSP) and project other than SCPSC and STSP of the Annual District Plan, 2011-12. Vide letter read as 3rd above, the Director of Ministry of Panchayati Raj informed that the amount eligible for the Development Grant component to Wayanad is only Rs. 6.46 crore and requested to refund the excess amount released to the extent of Rs. 11.40 crore to the Government of India by way of Demand Draft in favor of PAO, Ministry of Panchayati Raj, New Delhi.

Government have examined the matter in detail and are pleased to authorise the District Collector, Wayanad to draw Rs. 17.86 crore debiting the expenditure under the head of account "3451-00-101-53-BRGF (Plan)" and to refund the excess amount of Rs. 11.40crore scrupulously to Government of India by way of crossed Demand Draft in favour of PAO, Ministry of Panchayati Raj, New Delhi under intimation to Pay & Accounts Officer, Ministry of Panchayati Raj, Krishi Bhawan, New Delhi (by Registered post with acknowledgement) and also under intimation to the Director of Ministry of Panchayati Raj, Government of India, Jeevan Prakash LIC Buildings, 11th Floor, Kasturba Gandhi Marg, Connaught Place, New Delhi - 110 001; Local Self Government (FM) Department and Finance Department. The eligible amount of Rs.6.46 crore may be utilized as Development Grant as follows:


