ORDER

The 100th Central Sanctioning & Monitoring Committee (CSMC) meeting held on 7th September, 2011 at New Delhi approved the State Level DPR submitted for implementing total e-Governance modules in Kerala with the pilot in the Corporation of Thiruvananthapuram under National Mission Mode Project (NMMP) of JNNURM, with a project cost of Rs.1347.55 lakh subject to the following conditions:-

1. Provision will be made for inclusion of UID No. in the database.
2. The Corporation should adopt a technology and vendor independent open tendering process for procurement of hardware, software and other items.
3. A State Level Software solution will be developed with the concept of ULB deployable units which would have multi-tenancy and facilitate cities/towns in Kerala to expedite the adoption of e-Governance in Municipalities.
4. PPP should be used for service delivery through kiosks, Citizen Facilitation Centres, etc.
5. The State data centre and SWAN should be effectively used for hosting and deployment of the solution.

80% of the project cost for an amount of Rs.1078.04 lakh will be met from the ACA to be released by Govt. of India.

In the circumstances, Government are pleased to accord Administrative Sanction for the implementation of the Project "e-Governance in Municipalities in Kerala" with Pilot in Corporation of Thiruvananthapuram at an approved project cost of Rs.1347.55 lakh with 80% Central share plus ULB share subject to the above conditions.

The expenditure on this account will be debited under the head-of-account 2217-05-800-89(P) in the current year's budget.


