ORDER

As per the G.O read as second paper above, Government have accorded sanction for Rs.1.50 Crore each as special grant to the seven newly formed Municipalities for infrastructure development under the head of account 2217-80-800-11. As per the G.O read as third paper above, the above G.O was amended and accorded sanction for the allotment of the amount to the General Purpose Fund.

2.Accordingly, as per the G.O read as fifth paper above, Government have accorded sanction for additional expenditure to the tune of Rs.10,50,00,000/- (Rupees Ten Core Fifty Lakh only) as additional amount to the following seven newly formed Municipalities vide G.O read as first paper above, namely Karunagappally, Thrikkakara, Eloor, Maradu, Kottakkal, Nilambur, Neeleswaram.

3. In pursuance of the Government orders read as two to five above, Government hereby accord sanction for the release of a total amount of **Rs.10,50,00,000/- (Rupees Ten Crore Fifty Lakh only)** to the above said seven newly formed Municipalities @ Rs.1.50 Crore each towards additional amount . The transfer credit on this account is exempted from all Treasury restrictions.

4.The Director of Urban Affairs department will issue the required Letter of Authority (in form Annexure C-I) to the respective Municipality and to the Treasuries concerned for the release of funds in the matter as detailed in the G.O. read as sixth paper above.

5.And also, the Director of Urban Affairs Department is instructed to surrender the amount of Rs.10.50 Crore provided through SDG, October 2011 under the head of account " 2217-80-192-40(P) " and to take timely steps to regularise the additional expenditure through SDG before the close of the current financial year.
