ORDER

The Hon'ble High Court in its judgment dated 04.08.2011 in WP(C) 14102/2011 filed by IELC Trust Association, Nagarcoil, Tamil Nadu, has directed the 2nd respondent (Government) to consider and dispose of Exhibits P5 & P6 within a period of two months from the date of receipt of a copy of this judgment.

2. As per letter read as 2 nd paper above, the Chief Town Planner, has forwarded the regularization application along with technical recommendation. He has reported that the regularization application submitted by the Petitioner for the regularization of the construction of a commercial Building in Survey No.208/14 (Re -survey No 604/5) of Sulthan Bathery Village in Sulthan Bathery Grama Panchayat violates

220 (b) of KPR Act 1994 and Rules 24(3),24(5), 25, 24(11) and 102 (3) of KMBR 1999. The Chief Town Planner has also reported that building violates regularisation criteria No.1 & 3 of Appendix 1 of Kerala Building (Regularization of Unauthorised Construction) Rules 2010 and hence not recommended for regularisation .

3. In the above circumstances, the application for Regularization submitted by the Petitioner, Shri. I Nelson, Administrator, IELC, Trust Association, C/o ELIM Studio, Sulthan Bathery, Wayanad is rejected.

4. The directions contained in the judgment read above are thus complied with.


