ORDER

In the letter read as 1st paper above NABARD has sanctioned an amount of Rs. 7,79,32,000/- (Rupees Seven crore seventy nine lakhs thirty two thousand only) as loan for the Meenvallom Small Hydro Electric project of which a sum of Rs. 1,55,86,000/- (Rupees one crore fifty five lakhs eighty six thousand only) has been released as advance. As per the G.O read as second paper above, in principle sanction was accorded for Meenvallom project on the same terms and conditions on which NABARD sanctioned loan. As per the G.O read as 3rd, 4th and 5th paper above Government have sanctioned Rs. 89.75 lakh (Rupees Eighty nine lakh Seventy five thousand only) , Rs. 89.25 lakh (Rupees Eighty-nine lakh Twenty five thousand only) and 80.05 lakh (Rupees Eighty lakh and five thousand only) respectively for the project.

2. The Secretary, District Panchayat, Palakkad has requested Government to release an amount of Rs 51.19 lakh being the 7th instalment from RIDF XII loan by additional authorization vide letter read as 6th paper above.

3. In the above circumstances, Government are pleased to accord administrative sanction for the release of an amount of Rs. 51.19 lakh (Rupees Fifty one lakh and nineteen thousand only) from the Head of Account "6515-00-101-89-loans for NABARD assisted projects (P) to District Panchayat, Palakkad in connection with the Meenvallom Small Hydro Electric Project under RIDF scheme on the same terms and conditions on which NABARD loan is received.
