As per the GO read as 1st paper above Government had constituted a Selection Committee for preparing and recommending to Government, the ranked panel of persons found suitable for appointment as Ombudsman for MGNREGS in accordance with the approved instructions issued by Government of India. The ranked list prepared by the Selection Committee from the panel of suitable persons for consideration as Ombudsman under MGNREGS was notified as per the Government order read as 2nd paper above. The institution of the Ombudsman for MGNREGS is established with two persons each as the Ombudsman for MGNREGS in Palakkad, Wayanad and Idukki Districts and one person each as Ombudsman for MGNREGS in the remaining 11(eleven) Districts.

In accordance with the instructions issued by Government of India to set up the office of the Ombudsman in exercising the powers conferred under Section 27 of MGNREG Act 2005, the Government of Kerala are pleased to appoint the following persons as Ombudsman in the 14 districts of the state for MGNREGS for the corresponding Districts for redressal of grievancees and disposal of complaints relating to implementation of the MGNREGA Act and the schemes made under the Act by the State from the ranked panel notified as per Government order as 2nd paper above.

The office of the Ombudsman should be housed in the Poverty Alleviation Unit and the Secretarial assistance and other logistics would be provided by the Poverty Alleviation Unit of the District Panchayat concerned. The term of the office of Ombudsman for a tenure of 2 years extendable by one year based on performance appraisal or till the incumbent attains the age of 65 years, whichever is earlier. The powers and duties of Ombudsman will be strictly followed as per instructions on Ombudsman formulated under section-27(1) chapter III of the Ombudsman, in NREG Act. Remuneration will be fixed and intimated in due course
