**O R D E R**

Based on the declaration of the Hon'ble Minister (Finance) in the Budget Speech 2012-13, Commissioner for Rural Development as per the letter read above has submitted a proposal for according sanction and release of Rs.10.46 crores for granting financial assistance of Rs.1000/- each for female employees who have completed 100 days works in Mahatma Gandhi National Rural Employment Guarantee Scheme during the financial year 2011-12 for buying Uniform and Books for their children on the reopening of schools/colleges. Commissioner for Rural Development has reported that the total number of families falling under this category is 1,04,549 and the amount required for this purpose is Rs.10.46 crores.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for an amount of Rs.10.46 crores for granting an amount of Rs.1000/- each to 1,04,549 female employees who have completed 100 days of works in Mahatma Gandhi National Rural Employment Guarantee Scheme during the financial year 2011-12 for buying Uniforms and Books for their children when the schools/colleges re-open. The expenditure in this regard will be met from the Development Fund/General Purpose Fund/Own Fund of the respective Local Self Government Institutions concerned initially which will be reimbursed by Government immediately after the 1<sup>st</sup> batch of SDG is passed by Legislature.
