ORDER

Government of India as per the letter read as 1st paper above sanctioned a sum of Rs.9,00,000/- (Rupees Nine lakh only) as the balance installment of the Central Assistance for Capacity Building of the Local Bodies Under BRGF projects under the special component plan for Scheduled Castes (SCPSC) of the Annual Action Plan 2011-12, being released in financial year 2012-13.

2. And Government of India as per the letter read as 2nd paper above sanctioned a sum of Rs.3,00,000/- (Rupees Three lakh only) as the balance installment of the Central Assistance for Capacity Building of the local bodies under BRGF for the projects under the Scheduled Tribes Sub Plan (STSP) of the Annual Action Plan 2011-12, being released in financial year 2012-13.

3. And Government of India as per the letter read as 3rd paper above sanctioned a sum of Rs.55,00,000/- (Rupees Fifty Five lakh only) as the balance installment of the Central Assistance for Capacity Building of local bodies under BRGF for the implementation of the projects that do not fall in the Special Component Plan for Scheduled Castes (SCPSC) or Scheduled Tribes Sub Plan (STSP) categories of the annual Action Plan 2011-12, being released in financial year 2012-13.

4. The details of the releases by the Central Government so far are given below:-

4. In the above circumstances, Government are pleased to release

(1) an amount of **Rs.9,00,000/- (Rupees Nine lakh only)** as Central Assistance for Capacity Building of the Local Bodies Under BRGF projects under the special component plan for Scheduled Castes (SCPSC) of the Annual Action Plan 2011-12, being released in financial year 2012-13;

(2) a sum of **Rs.3,00,000/- (Rupees Three lakh only)** as Central Assistance for Capacity Building of the local bodies under BRGF for the projects under the Scheduled Tribes Sub Plan (STSP) of the Annual Action Plan 2011-12, being released in financial year 2012-13; and

(3) a sum of **Rs.55,00,000/- (Rupees Fifty Five lakh only)** as Central Assistance for Capacity Building of local bodies under BRGF for the implementation of the projects that

do not fall in the Special Component Plan for Scheduled Castes (SCPSC) or Scheduled Tribes Sub Plan (STSP) categories of the Annual Action Plan 2011-12, being released in financial year 2012-13.

5. The Director, Kerala Institute of Local Administration (KILA), Thrissur is authorised to draw the grants amounting to **Rs.67 lakh (Rupees Sixty Seven lakh only)** (= 9.00+ 3.00+55.00) debiting the expenditure to the head of account "**3451-00-101-58-BRGF (ACA) (Plan V)**" towards the Capacity Building of the Local Bodies Under BRGF for the Annual Action Plan 2011-12 released in the Financial year 2012-13.

6. The fund should be utilized and accounts should be maintained in accordance with the provisions contained in chapter 4 of the BRGF guidelines and utilization details and quarterly progress reports shall be submitted by the Director, KILA, Thrissur to Government of India, with a copy to Local Self Government Department in Government promptly, vis a vis targets indicated in the approved annual plan and placed on the *plan plus* portal also regularly.


