### **O R D E R**

As per the Order read as 1<sup>st</sup> paper above Government have notified the ranked list for Ombudsman for Mahatma Gandhi National Rural Employment Guarantee Scheme. Government have appointed the persons as Ombudsman in the 14 districts of the state for Mahatma Gandhi National Rural Employment Guarantee Scheme for redressal of grievances and disposal of complaints relating to the implementation of the Mahatma Gandhi National Rural Employment Guarantee Act and Schemes vide order read as 2<sup>nd</sup> paper above. As per the letter read as 3<sup>rd</sup> paper above, Sri. P. Nandan (appointed as Ombudsman for Malappuram District) has informed that he is not interested to join as Ombudsman.

In the circumstances Government are pleased to appoint Sri. A. Shajahan, who is the second candidate in the rank list for Ombudsman as Ombudsman in Malappuram District.

The office of the Ombudsman should be housed in the Poverty Alleviation Unit and the Secretarial assistance and other logistics would be provided by the Poverty Alleviation Unit of the District Panchayat concerned. The term of the office of the Ombudsman for a tenure of 2 years extendable by one year based on performance appraisal or till the incumbent attains the age of 65 years, whichever is earlier. The powers and duties of Ombudsman will be strictly followed as per instructions on Ombudsman formulated under section-27(1) chapter III of the Ombudsman, in NREG Act. Remuneration will be fixed and intimated. The candidate will join duty within 15 days from the date of receipt of this Order.
