Government after having examined the matter in detail, are pleased to accord permissive sanction to Local Self Government Institutions for purchasing and using the following products at cost not exceeding the rate quoted by them.

- 1) The **mother culture as wettable powder** developed by the Department of Agricultural Micro Biology College of Agriculture, Vellayani @ Rs.60 per kg.
- 2. The **Pelrich composorb**, a composting agent developed M/s Pelican Biotech and Chemical Labs Pvt. Ltd, Cherthala, Alappuzha @ Rs.60 per 5 packet.

Sanction is accorded for using the above two products for composting process for a period of 1 year on trial basis and extension of the period shall be subject to effectiveness of the products.
