### ORDER

- 1. In the Government Order read as 1<sup>st</sup> paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- 2. As per the Government Order read as 7<sup>th</sup> paper above sanction was accorded for the release of 1<sup>st</sup> installment of Funds for Expansion and Development for the month of May 2012 in pursuance of the Government Orders read as 1<sup>st</sup>, 4<sup>th</sup> and 6<sup>th</sup>.
- 3. As per the Government Order read as 7<sup>th</sup> paper above sanction was accorded for the transfer credit of ₹ 209,00,50,100/- (Rupees Two hundred and Nine crore Fifty Thousand and one hundred only) from the Consolidated Fund under Major Head of Account, '3604 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 Deposits of Local Funds' to release the first installment due for the month of May 2012 being the Funds for Expansion and Development to Local Self Government Institutions. Sanction

was also accorded for the release of ₹ 209,00,50,100/- (Rupees Two hundred and Nine crore Fifty Thousand one hundred only) being \$\frac{1}{10}\$th of the net allocation earmarked to the Local Self Government Institutions in respect of Funds for Expansion and Development under different sectors as per the distribution in Appendix - IV to the detailed Budget Estimates 2012-13 (excluding Funds earmarked for Kerala Local Government Service Delivery. Project with World Bank assistance and the release under the 13th Finance Commission award and share as per tax effort criterion) and release of the Special incentive to award winning Local Governments for 2010-11 as ordered in G.O. read as sixth paper above.

- 4. In the circumstances, Government are pleased to release <sup>1</sup>/<sub>10</sub><sup>th</sup> of the current years budget provision allocated to Local Self Government Institutions amounting to ₹ 209,00,50,100/- (Rupees Two hundred and Nine crore Fifty Thousand one hundred only) as 1<sup>st</sup> installment of Expansion and Development Fund for the month of May 2012 as per the entitlement envisaged in Appendix IV to the detailed Budget Estimates 2012-13.
- 5. The Controlling Officers (Director of Panchayats, Director of Urban Affairs, Commissioner for Rural Development) will issue necessary orders indicating the institution wise release of funds (net amount) and Letter of Authority (in form Annexure C-I) for each Public Account viz VPFA II (a), VPFA II (b), VPFA II (c), MFA II (a), MFA II (b), MFA II (c), BPFA II (a), BPFA II (b), BPFA II (c) to the respective Local Self Government Institution and to the Treasuries concerned for the release of monthly installment for May 2012 under Category-A, Development Expenditure Fund, based on the sectorwise distribution, excluding Funds earmarked for Kerala Local Government Service Delivery Project with World Bank Assistance and the release under the 13<sup>th</sup> Finance Commission Award, shown in the Appendix IV to the Detailed Budget Estimates, 2012-13 and release of the Special incentive for 2010-11 as ordered in G.O.read as sixth paper above. In the case of Grama Panchayats, Deputy Director of Panchayats of the respective District will sign the Letter of Authority to the Grama Panchayats under their jurisdiction on the strength of the proceedings releasing the funds (indicating the amount released to each Grama Panchayat with District - wise total) to be issued by the Director of Panchayats.
- 6. In this release the deduction in shortfall (1/10th of the total deduction) would be done in the general sector only

- 7. The controlling officers are also informed that they would calculate the amount for the deduction in SCP/TSP for shortfall to each LSGI in the same ratio for which allocation has already been provided vide statement appended to the G.O read as seventh paper and intimate the Government before 4th August 2012, so as to adjust the short fall in the SCP / TSP fund in the next releases based on details furnished.
- 8. The Director of Panchayats is directed to deduct an amount of Rs.5,72,639/- (Rupees Five lakh Seventy Two thousand Six hundred and Thirty Nine only) from the allotment to Kundara Grama Panchayat in two instalments and remit the amount to Central Government as ordered in G.O. read as 8<sup>th</sup> paper above.
- 9. The special incentive amount to the tune of Rs.1,50,00,000/- (Rupees One Crore Fifty lakh only) for 2010-11 will be released to the award winning Local Governments as ordered in G.O.read as 6<sup>th</sup> paper above.
- 10. Accordingly, Government are pleased to allot the following amount as 1<sup>st</sup> installment of Development fund to the 14 District Panchayats and 5 Corporations as shown below;
