### O R D E R

As per Section 7 subsection 1 of the Mahatma Gandhi National Rural Employment Guarantee Act of 2005, if an applicant for employment under the scheme is not provided employment within 15 days of receipt of the application he/she shall be entitled to a daily unemployment allowance. By the powers conferred by Section 32(1) of the Act, the State Government by notification and consistent with the Act can make rules regarding

- a) The terms and conditions for determining eligibility for unemployment allowance.
- b) The procedure for payment of unemployment Allowance.

Accordingly, vide letter read above, the Mission Director, MGNREGS has requested to constitute an Expert Committee to prepare the draft rules for the payment of Unemployment Allowance and other related issues under MGNREGS.

Considering the above, Government hereby constitute a committee of experts as shown below to prepare draft rules for the payment of Unemployment Allowance and other related issues.
