ORDER

1. As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.

2. As per the Government Order read as 7th, 9th, 11th, 13th, 15th and 17th papers above sanction was accorded for the release of 1st, 2nd, 3rd, 4th, 5th and 6th instalment of funds for Traditional Functions for the month of April, May, June, July, August and September 2012.

3. As per Government Order read as 18th paper above sanction was accorded for the drawal of total amount of **Rs.60,58,78,854/- (Rupees Sixty crore Fifty Eight lakh Seventy Eight thousand Eight hundred and Fifty Four only)** from the budget provision under head of account 3604-00-200-93 (N.P.) being the 7th installment of Funds for Traditional Functions for the month of October 2012. Out of this, an amount of **Rs.2,91,23,557/- (Rupees Two Crore Ninety One lakh Twenty Three thousand Five hundred and Fifty Seven only)** is transfer credited to the Major head of account "2515 - other Rural Development Programmes - 00 - 001 - 05 - 92/91/90-" as per the G.O read as 5th paper to adjust the salary cost in respect of Engineering Cadre under Local Self Government

Institutions as ordered in the Government Order read as 3rd paper above and **Rs. 57,67,55,297/- (Rupees Fifty Seven Crore Sixty Seven lakh Fifty Five thousand Two hundred and Ninety Seven only)** was transfer credited to the Deposit Account of Local Self Government Institutions under State's Public Account being 7th installment of Funds for Traditional Functions for the month of October 2012.

4. Accordingly, sanction is accorded for the release of **Rs. 57,67,55,297/- (Rupees Fifty Seven Crore Sixty Seven lakh Fifty Five thousand Two hundred and Ninety Seven only)** being the 7th installment of Funds for Traditional Functions for the month of October 2012 after adjusting the salary cost of Engineering cadre under Local Self Government Institutions.

5. The Director of Panchayats is authorised to deduct an amount of **Rs.68,37,812/- (Rupees Sixty Eight lakh Thirty Seven thousand Eight hundred and Twelve only)** being monthly recovery of excess gap fund drawn by 85 Grama Panchayats and monthly amount to be released to each of the 85 Grama Panchayats as detailed in the statement appended as Annex I of the G.O. read as 18th paper above.

6. The distribution of funds among the Local Self Government Institutions effected are as shown in the statement appended to Government Order read as 18th paper above. The amount so transfer credited is exempted from treasury restrictions.

7. The Controlling Officers will release the 7th installment to the Local Self Government Institutions concerned, being $\frac{1}{12}$ th of the funds earmarked for Traditional Functions (after adjusting the salary cost of Engineering Wing), in accordance with the guidelines prescribed in Para 3 of the Government Order read as 1st paper above subject to the conditions laid down in the circular cited. Necessary instructions have been given to the Controlling Officers for deducting the amount towards the salary cost of engineering staff of LSGIs for the year 2012-13 and the statement depicting the institution wise details of the amount is also issued vide letter read as 6th above.

8. The progressive amount of release of funds to the Local Self Government Institution for Traditional Functions (General Purpose Fund) during 2012-2013 including the release as per this order will be Rs. 425,48,27,602/-

9. Accordingly Government are pleased to release the 7th installment of General Purpose Fund to District Panchayats and Corporations as follows.

The Controlling Officers will issue necessary orders indicating the institution - wise release of the fund (net amount) and Letter of Authority (in form Annexure C-I) to the respective Local Self Government Institution and to the Treasuries concerned for the monthly installment for October 2012 based on distribution as in Appendix IV to the Detailed Budget Estimates 2012-13 and the deductions ordered in the G.O. read as third, fifth and 18th above. In the case of Grama Panchayats, Deputy Director of Panchayats of the respective District will sign the Letter of Authority to the Grama Panchayats under their jurisdiction on the strength of the proceedings releasing the funds (specifying the amount released to each Grama Panchayat with District – wise total) to be issued by the Director of Panchayats.


