### **ORDER**

1. In the Government Order read as 1<sup>st</sup> paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.

2. As per the Government Order read as 7<sup>th</sup>, 9<sup>th</sup>, 11<sup>th</sup>, 13<sup>th</sup>, 15<sup>th</sup> and 17<sup>th</sup> papers above sanction was accorded for the release of first, second, third, fourth, fifth and sixth instalments of funds for Expansion and Development for the month of May, June, July, August, September and October 2012.

3. As per the Government Order read as 18<sup>th</sup> paper above sanction was accorded for the release of seventh instalment of Funds for Expansion and

Development for the month of November 2012 in pursuance of the Government Orders read as first and fourth.

4. As per the Government Order read as 18<sup>th</sup> paper above sanction was accorded for the transfer credit of ₹ **207,50,50,100/- (Rupees Two hundred and Seven crore Fifty lakh Fifty Thousand and one hundred only)** from the Consolidated Fund under Major Head of Account, '3604 - Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 - Deposits of Local Funds' to release the seventh instalment due for the month of November 2012 being the Funds for Expansion and Development to Local Self Government Institutions. Sanction was also accorded for the release of ₹ **207,50,50,100/- (Rupees Two hundred and Seven crore Fifty lakh Fifty Thousand and one hundred only)** being  $\frac{1}{10}$ <sup>th</sup> of the net allocation earmarked to the Local Self Government Institutions in respect of Funds for Expansion and Development under different sectors as per the distribution in Appendix - IV to the detailed Budget Estimates 2012-13 (excluding Funds earmarked for Kerala Local Government Service Delivery Project with World Bank assistance and the release under the 13<sup>th</sup> Finance Commission award and share as per tax effort criterion)

5. In the circumstances, Government are pleased to release  $\frac{1}{10}$ <sup>th</sup> of the current years budget provision allocated to Local Self Government Institutions amounting to ₹ **207,50,50,100/- (Rupees Two hundred and Seven crore Fifty lakh Fifty Thousand and one hundred only)** as seventh instalment of Expansion and Development Fund for the month of November 2012 as per the entitlement envisaged in Appendix IV to the detailed Budget Estimates 2012-13.

6. The progressive amount of funds released for Expansion and Development to LSGIs during 2012-13 including the release as per this G.O. is Rs. 1798,22,78,700/- (Rupees One thousand Seven hundred and Ninety Eight Crore Twenty Two lakh Seventy Eight thousand and Seven hundred only)

7. The Controlling Officers (Director of Panchayats, Director of Urban Affairs, Commissioner for Rural Development) will issue necessary orders indicating the institution wise release of funds (net amount) and Letter of Authority (in form Annexure C-I) for each Public Account viz VPFA II (a), VPFA II (b), VPFA II (c), MFA II (a), MFA II (b), MFA II (c), BPFA II (a), BPFA II (b), BPFA II (c) to the respective Local Self Government Institution and to the Treasuries concerned for the release of monthly instalment for November 2012 under Category-A, Development Expenditure Fund, based on the sector-wise distribution, excluding Funds earmarked for Kerala Local Government Service Delivery Project with World Bank Assistance and the release under the 13<sup>th</sup> Finance Commission Award, shown in the Appendix IV to the Detailed Budget Estimates, 2012-13. In the case of Grama Panchayats, Deputy

Director of Panchayats of the respective District will sign the Letter of Authority to the Grama Panchayats under their jurisdiction on the strength of the proceedings releasing the funds (indicating the amount released to each Grama Panchayat with District – wise total) to be issued by the Director of Panchayats.

8. In this release also the deduction in shortfall (1/10<sup>th</sup> of the total deduction) would be done in the general sector only.

9. The controlling officers are also informed that they would calculate the amount for the deduction in SCP/TSP for shortfall to each LSGI in the same ratio for which allocation has already been provided vide statement appended to the GO read as 18<sup>th</sup> paper and intimate the Government so as to adjust the short fall in the SCP/ TSP fund in the forthcoming releases based on details furnished.

10. Accordingly, Government are pleased to allot the following amount as seventh instalment of Development fund to the 14 District Panchayats and 5 Corporations as shown below;


