ORDER

Shri. Arjun Sharma. J. S, S/o. Late. P. Sreelal, who died in harness on 09.05.2006 while working as L. D. Clerk (HG) , Chadayamangalam Gramapanchayat, Kollam district, applied for employment assistance under Compassionate Employment Scheme as per the application read as 2nd paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 17 years and 2 days.

The applicant is 20 years old as his date of birth being 11.12.1992. He has passed Higher Secondary Examination. The request is for the appointment in the post of Lower Division Clerk and he is qualified for that post.

The Director of Panchayats and the District Collector, Kollam as per the letters read as 3rd and 4th papers above have recommended the request of Shri. Arjun Sharma. J. S. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the son and a real dependent of the deceased. None of the dependants of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Kollam as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs.82,920/- (Rupees eighty two thousand nine hundred and twenty only).

In the above circumstances, Government are pleased to appoint Shri. Arjun Sharma. J. S, S/o. Late. P. Sreelal, L. D. Clerk (HG) , Chadayamangalam Gramapanchayat, Kollam district in the existing/arising vacancy of Lower Division Clerk in Kollam District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above.

The Director of Panchayats shall issue formal appointment order to Shri. Arjun Sharma J.S. in this regard and verify that the conditions stipulated in the GO read as 1st paper above are thoroughly fulfilled.

The Deputy Director of Panchayats, Kollam shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to Shri. Arjun Sharma. J, S., the dependant of late. P. Sreelal who died in harness on 09.05.2006 while working as L. D. Clerk (HG), Chadayamangalam Gramapanchayat, Kollam, as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
