ORDER

Shri. Santhosh Kumar. P. K., S/o. late. P. Kuttan Pillai, who died in harness on 16/06/2011 while working as Part Time Watcher, Kulanada Gramapanchayat in Pathanamthitta District applied for employment assistance under Compassionate Employment Scheme as per the application read as 3rd paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 22 years, and 15 days.

The applicant is 39 years old as his date of birth being 10.05.1973. He has passed the SSLC. The request is for the appointment in the post of Part Time Contingent post and he is qualified for that post.

The Director of Panchayats and the District Collector, Pathanamthitta as per their letters read as 4th and 5th papers above have recommended the request of Shri. Santhosh Kumar. P. K. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the son and a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Pathanamthitta as per the letter read as 5th paper above has reported that the annual family income of the deceased Government servant is Rs.22,000/- (Rupees Twenty two thousand only).

As the applicant is married, the Tahasildar, Kozhencherry as per the certificate read as 6th paper above has certified that even after his marriage, Shri. Santhosh Kumar. P. K. was a dependent of his father till his father's death.

In the above circumstances, Government are pleased to appoint Shri. Santhosh Kumar. P. K., S/O. late. P. Kuttan Pillai, Part Time Watcher, Kulanada Gramapanchayat, Pathanamthitta District in the existing/arising vacancy in a Part Time Contingent Post under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order, read as 1st and 2nd papers above.

The Director of Panchayats shall issue formal appointment order to Shri.Santhosh Kumar. P. K. in this respect and shall thoroughly verify that the conditions stipulated in the Government Orders read as 1st and 2nd papers above are fulfilled

The Deputy Director of Panchayats, Pathanamthitta shall make necessary entries in the Establishment Register regarding grant of employment to the dependant as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.

The seniority of the applicant for getting posting is as per the direction in para 1(iii) of the Government Order read as 2nd paper above.
