2. The State Information Commission as per their letter read as 3rd paper above, has requested to transfer the documents of 25 cents of land of defunct Kerala State Rural Development Board in Survey No. 2815 of Thiruvananthapuram Taluk, Vanchiyoor Village to State Information Commission.

Kerala Urban and Rural Development Finance Corporation Ltd is the sole Government agency now catering all the developmental needs of the local bodies, which was earlier served by the Kerala State Rural Development Board. The office of the Kerala Urban and Rural Development Finance Corporation Ltd is functioning on a rented building with limited facilities and it is planning to expand its functionality.

Government have examined the matter in detail and are pleased to accord sanction to transfer the 25 cents of land of defunct Kerala State Rural Development Board in Survey No. 2815 of Thiruvananthapuram Taluk, Vanchiyoor Village along with the existing building to Kerala Urban and Rural Development Finance Corporation Ltd for their functioning.


