The Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme vide letter read as 3<sup>rd</sup> paper above has requested to set qualifications and eligibility of State Level Quality Monitors and there after invite applications after obtaining necessary approval of the Government as per the decision of SEGC read as 3<sup>rd</sup> paper above.

Scheme has requested that in order to fulfil the responsibilities entrusted with the State Level Quality Monitor, a team of experts having experience in social work, engineering, social mobilization implementation of poverty alleviation programmes and ability to comprehend field level assume effectively should be assigned the task of quality monitoring in the state and hence retired officials of the following departments and retired professors having the following eligibility may be considered for inviting applications.
