## **ORDER**

Government of India vide letter read as 1st paper above sanctioned a sum of Rs.2,32,00,000/- (Rupees Two Crore Thirty Two lakh only) as Central Assistance under the Development Grant component of the Backward Regions Grant Fund (BRGF) being the first release of development grant for the district plan 2012-13, to the Government of Kerala for Palakkad District for implementation of the projects under the Special Component plan for Scheduled Caste (SCPSC) of Annual District 2012-13.

2. And Government of India as per letter read as 2<sup>nd</sup> paper above sanctioned a sum of Rs.21,00,000/- (Rupees Twenty One lakh only) as Central Assistance under the Development Grant component of the BRGF, being the first release of development grant for the district plan 2012-13, to Government of Kerala for

Palakkad District for implementation of the projects under the special component plan for Scheduled Tribes Sub Plan (STSP) of the Annual District Plan 2012-13.

3.And Government of India as per letter read as 3rd paper above sanctioned a sum of Rs.11,49,00,000 (Rupees Eleven Crore Forty Nine lakh only) as Central Assistance under the Development Grant component of the BRGF, which is being the first release of development grant for the district plan 2012-13, to Government of Kerala for Palakkad District for implementations of projects that do not fall in the Special Component plan for Scheduled Castes (SCPSC) or Scheduled Tribes Sub Plan (STSP) categories of the Annual District Plan 2012-13.

In the above circumstances, Government are pleased to release:-

- 1. an amount of Rs.2,32,00,000 (Rupees Two crore Thirty Two lakh only) as Central Assistance under the Development Grant component of the BRGF to Government of Kerala for Palakkad District for implementation of the projects under the Special Component plan for Scheduled Caste (SCPSC) of the Annual District Plan 2012-13.
- 2. an amount of Rs.21,00,000 (Rupees Twenty One lakh only) as Central Assistance under the Development Grant component of the BRGF to Government of Kerala for Palakkad District for implementation of the projects under the Special Component plan for Scheduled Tribes Sub Plan (STSP) of the Annual District Plan 2012-13.
- 3. an amount of Rs.11,49,00,000 (Rupees eleven crore Forty Nine lakh only) as Central Assistance under the Development Grant component of the BRGF to Government of Kerala for Palakkad District for implementation of the projects that do not fall in the Special Component Plan for Scheduled Castes

(SCPSC) or Scheduled Tribes Sub-Plan (STSP) categories of Annual District Plan 2012-13.

- 5. The District Collector is authorised to draw the grants amounting Rs. 14.02 crore (Total Rupees Fourteen crores two lakhs only) debiting the expenditure to the head of account "3451-00-101-58-BRGF (ACA)" towards the first release of development grant for the Palakkad district plan 2012-13.
- 6. The funds should be utilized and accounts should be maintained in accordance with the provisions contained in chapter 4 of the BRGF guidelines and utilization details and quarterly progress reports shall be submitted by the District Collector, Palakkad to Government of India, with a copy to Local Self Government Department in Government promptly, vis a vis targets indicated in the approved annual plan and placed on the *plan plus* portal also regularly.
