ORDER

As per G.O read above, Government had authorised District Collector, Wayanad to draw Rs.17.86 crore debiting expenditure under head of account "3451-00-101-53-BRGF (Plan)" and to refund the excess amount of Rs. 11.40 crore scrupulously to Government of India by way of crossed Demand Draft in favour of Poverty Alleviation Unit, Ministry of Panchayatyi Raj, New Delhi. District Collector Wayanad vide letter read as 2nd paper above, had requested Government to give sanction to refund the above amount by RTGs method, since issuing Demand Draft above Rs. 10 lakhs at a time was against the Bank fund transfer norms. Now Government of India vide letter read as 3rd paper above have informed that the excess amount of Rs. 11.40 crore released in 2011-12 under BRGF Development Grant component had already been refunded and received in Ministry's account. And Finance Department has advised to direct District Collector, Wayanad to refund Rs.11.40 Crore (BRGF Development Grant) to the State account immediately.


In the circumstance Government are pleased to order not to carry out the direction contained in the G.O. read above to refund the amount of Rs. 11.40 crore to Government of India by way of Demand Draft, instead District Collector, Wayanad will refund Rs. 11.40 crore to the State account in the head of account "3451-00-911-Recoveries of overpayment" immediately and report the compliance to Government with a copy of the chalan of remittance. The direction contained in G.O. read above stands modified to this extent.
