NABARD as per their letter read as 1<sup>st</sup> paper above has accorded sanction for 27 projects under RIDF XV PPID & VDP Scheme. Government as per Government Order read as 2<sup>nd</sup> paper above have accorded administrative sanction for the 18 projects worth Rs.90 lakh sanctioned to Manjeswaram Block Panchayath and Projects worth Rs.135.80 lakh sanctioned to Kollengode Block Panchayath under RIDF XV-PPID. The Commissioner for Rural Development in his letter read as 3<sup>rd</sup> paper above has requested Government to accord administrative sanction for implementing this remaining 5 projects sanctioned by NABARD under RIDF XV VDP Scheme with a total project cost of Rs.145.25/- lakh ( NABARD share - 116.20 lakh and LSG institutions share - 29.05 lakh) to the Koduvayoor Grama Panchayath (4 projects) and the Maloor Grama Panchayath (1 project) by following guidelines of NABARD.

Government have examined the matter in detail and are pleased to accord sanction to Commissioner for Rural Development to implement the 4 projects worth Rs.70.25 lakh sanctioned to Koduvayoor Grama Panchayath in Palakkad District and 1 project worth Rs.75/- lakh (Total project cost 145.25 lakhs) of Maloor Grama Panchayath in Kannur District under RIDF XV.VDP as per the norms laid down by NABARD.
