O R D E R

As per the letter read as 1<sup>st</sup> paper above Government of India have informed that the 31<sup>st</sup> Steering Committee meeting on IWMP held on 22.02.2013 has suggested that the State level Nodal Agency (SLNA), Kerala should organize exposure visits for field staff to neighbouring states like Karnataka, Tamil Nadu and Andhrapradesh.

2. Accordingly as per letter read as 2<sup>nd</sup> paper above, Commissioner for Rural Development has put forth recommendation to conduct exposure visits to Andhrapradesh as the 1<sup>st</sup> phase and suggested the names of officers to be deputed for field visit in consultation with the Senior Officials in Andhrapradesh and also sought sanction authorizing the Chief Executive Officer of SLNA to select suitable district and Block Level Officials and to depute them for the second phase of exposure visit to Karnataka or Tamil Nadu.

3. Government have examined the matter in detail and are pleased to accord sanction for the deputation of the following officers as suggested by Commissioner for Rural Development in the first phase of exposure visit to Andhrapradesh.
