**ORDER**

As per GO referred 2<sup>nd</sup> paper above, Government have ordered among other things that a portion of the existing financial assets of Kerala State Rural Development Board will be deposited as 'pension fund' and the interest thereon will be deposited as used for meeting pension cost of the existing pensioners/ retirees. It was also ordered that the Special Officer, Kerala State Rural Development Board (defunct) will furnish proposal to fix the quantum of 'pension fund'.

2. Accordingly, the Special Officer, Kerala State Rural Development Board, vide his letter read as 3<sup>rd</sup> paper above has furnished proposal for creation of pension fund. Government have examined the matter in detail and are pleased to accord sanction to Special Officer, Kerala State Rural Development Board to deposit an amount of 3 crores as pension fund in the name of Managing Director, Kerala Urban and Rural Development Finance Corporation Ltd from the financial assets of KSRDB as fixed deposit in an interest bearing special Treasury Savings Bank account, so that the monthly pension of the pensioners/ Family pensioners can be met with

The Managing Director, Kerala Urban and Rural Development Finance Corporation Ltd. is hereby authorized to disburse the monthly pension by operating the pension fund granted as above to the pensioners/ family pensioners of the erstwhile KSRDB. He is also authorized for effecting the payment of revision of pension/ revision of Dearness Allowance or any other related matters in future as per the relevant rules after obtaining consent from Government.
