ORDER

Based on the findings of the Vigilance Enquiry Report in VE 11/2010/ERK, a vigilance case was registered as VC 03/11/ERK on 25.10.2011 and the Director, Vigilance & Anti Corruption Bureau, Thiruvananthapuram had recommended to suspend Sri.K.K.Kunjucherukkan, Former Village Extension Officer and Member Secretary of Kudumbasree, CDS, Akalakkunnam Grama Panchayath from service for the smooth investigation of the case vide letter read as 1st paper above.

As per Government order read as 2nd paper above Sri.K.K.Kunjucherkkan was placed under suspension based on the above recommendation. Now the suspension Review Committee held on 12.06.2013 has recommended to reinstate Sri.Kunjucherukkan, former Village Extension Officer and Member Secretary of Kudumbasree, CDS, Akalakunnam Grama Panchayath in a non-sensitive post outside the district where the offence took place.

Government have examined the case in detail and are pleased to accord sanction to reinstate Sri.Kunjucherukkan, former Village Extension Officer and Member Secretary, Kudumbasree, CDS, Akalakunnam Grama Panchayath in a non-sensitive post outside the

district where the offence took place pending the vigilance case registered against him.
