O R D E R

In the Budget speech for the year 2013-14, vide para 57, the Hon'ble Finance Minister has announced a scheme for distribution of Onakodi to female Mahatma Gandhi National Rural Employment Guarantee Scheme workers, who have completed 100 days job under Mahatma Gandhi National Rural Employment Guarantee Scheme. A token provision is also provided under the Head of Account 2505-02-101-95 for implementing scheme in 2013-14.

2. The Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme has reported that on the basis of MIS report of Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2012-13, 3,40,312 women workers are found eligible for getting free Onakkodi and an amount of Rs.13,61,24,800/- is needed for the purpose @ Rs.400/unit. The Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme vide his letter read as 1st paper had requested to accord administrative sanction for the scheme. Since the time left for is limited, the Mission Director

has suggested for limited tender with Hantex and Handveev for supplying the materials as per requested specifications at the rate of Rs.400/- per packet.

3. Government have examined the matter in detail and are pleased to accord Administrative Sanction for distribution of Onakkodi to 3,40,312 women workers who are found eligible for getting free Onakkodi at a total cost of Rs.13,61,24,800/- (Thirteen crores Sixty one lakh Twenty Four Thousand and Eight Hundred Only) $(340312 \times \text{Rs.}400/- = 13,61,24,800/-)$ as per the scheme submitted by the Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme as per reference read above.

4. Since the time left for is limited and also considering the expectancy, Government also order that the scheme will be implemented based on limited tender with Handveev and Hantex.
