### ORDER

As per the Government Order read above sanction has been accorded for conducting 3 day Global Conference on Local Governance from 13/01/2014 to 15/01/2014 in Thiruvananthapuram. In order to ensure the proper conduct of the event Government are pleased to sanction the following arrangements and appointments.

1. An office at Swaraj Bhavan shall be opened with staff on contract / working arrangement / deputation basis.
2. The Director of Panchayats shall provide 3 computers, printers and furniture on loan basis
3. Phone and Fax connection for the office of the Chief Co-ordinator shall be obtained.
4. Shri.J.R.Gopakumar, Additional Director of Panchayats (Rtd) shall be appointed as the Programme Manager on contract basis for six months (from 20<sup>th</sup> August <sup>2013</sup> to 31<sup>st</sup> January 2014) and shall be given remuneration at Rs. 25,000/p.m.
5. Shri.G. N. Hari kumar , Junior Superintendent ,O/o the Director of Panchayat shall be appointed as the Assistant Programme Manager on working arrangement.
6. A Technical Assistant shall be appointed on working arrangement from Information Kerala Mission.
7. In order to meet urgent requirements, an amount of Rs .2,00,000/- (Rupees Two lakhs only) shall be drawn from the amount provided to the State Performance Audit Authority and remitted to the Bank Account to be opened in the name of Chief Co-ordinator and Finance Committee Convenor,

on condition that the amount so drawn shall be remitted back, as and when the budget allotment for the event is drawn. The Under Secretary LSG(AA)Dept is authorised to effect the transaction.

8. Local Self Govt. (FM) Department shall move the proposal for Supplementary Demand for Grant of ₹ 2 crores for availing budget provision as stipulated as per the order read above.
