O R D E R

As per the letter read as 1st paper above Government of India have accorded sanction to organize Regional SARAS fair at Kannur from 01.09.2013 to 13.09.2013. Commissioner for Rural Development in his letter read as 2nd paper above has informed that the total estimated expenditure for conducting the fair is Rs.92 lakhs (Rupees Ninety Two Lakhs only). The central assistance for conducting the fair is Rs.20 lakhs only. In the letter read as 3rd paper above Commissioner has furnished the district wise details of fund available with Poverty Alleviation Unit, and the balance fund available in the SGSY Account of Poverty Alleviation Units is Rs.460.44 lakhs only. Commissioner has informed that Rs.5 lakhs only can be met through sponsorship from banks and other institutions. Hence requested to accord sanction to meet the balance amount of Rs.67 lakhs needed for the SARAS fair from the SGSY fund available with the Poverty Alleviation Unit of the respective districts.

Government have examined the case in details and are pleased to accord permissive sanction to commissioner for Rural Development to meet Rs.67 lakhs (Rupees Sixty Seven lakhs only) from SGSY fund available with Poverty Alleviation Unit subject to the condition that Project Director, Poverty Alleviation Unit, Kannur will incur the expenditure for the fair ensuring maximum economy and shall get the account of the fair audited by Chartered Accountant within one month of completion of the fair.
