O R D E R

Commissioner for Rural Development as per the letter read as 1<sup>st</sup> paper above has informed that the Rural Development Department is proposed to organize trade fair in all district except in Wayanad, Idukki, Pathanamthitta, Kasargod from 10.09.2013 to 14.09.2013. The Commissioner for Rural Development as per the letter read as 3<sup>rd</sup> paper above has proposed to meet the expenses from SGSY fund with Poverty Alleviation Unit amounting to Rs.33,73,800/- for 9 district as given in annexure. Beside this an amount of Rs.2,15,000/- is also required for meeting the transportation cost and other incidental expenses for 4 districts where the IRDP fair is not proposed to be held. As per the Government Order read as 1<sup>st</sup> paper above an amount of Rs.10 lakhs was sanctioned for granting assistance for the district level marketing outlet

of rural product in which organizing trade fair for rural products at district level. Hence Commissioner has requested for sanction to meet Rs.6 lakhs (Rupees Six lakhs only) from 10 lakhs sanctioned under the Head of Account 2515-00-102-41 (02)

2. Government have examined the case in details and are pleased to accord sanction to meet Rs.35.88 lakhs (Rupees Thirty five lakhs and Eighty eight thousand) (33.73800+ 2.15) from the unutilized SGSY fund kept with Poverty Alleviation Unit as detailed in annexure given and also to expend Rs.6 lakhs from the Head of Account 2515-00-102-41(02) for the conduct of IRDP SGSY trade fair from 10.09.2013 to 14.09.2013.
