ORDER

Sri.Sahad.S, L.D.Typist, Block Panchayath Office, Konni in his application read as 4th paper above has requested Government to sanction an amount of Rs.1,15,000/- (Rupees One Lakh fifteen thousand Only) as Interest Free Medical Advance for his son's cardiac treatment at Sree Chithira Thirunal Institute of Medical Sciences & Technology, Thiruvananthapuram. The Commissioner for Rural Development has also recommended the application of Sri.Sahad.S, L.D.Typist as per the letter read as 5th paper above.

Government have examined the matter in detail in the light of the Government Orders read above and are pleased to accord sanction to an amount of Rs.1,15,000/- (Rupees One Lakh Fifteen Thousand only) as Interest Free Medical Advance Sri.Sahad.S, L.D.Typist, Block Panchayath Office, Konni for his son's cardiac treatment at Sree Chithira Thirunal Institute of Medical Sciences & Technology, Thiruvananthapuram by debiting the expenditure under the head of account "7610-00-800-95(02) IFMA to Non Gazetted Officers" in the current year's Budget subject to the conditions specified in the Government Orders read above. The Utilisation Certificate duly countersigned by the Medical Officer of the Institution should be produced within 3 months from the date of drawal and the advance should be settled within 6 months. In case of default, penal interest @ 12% will be charged. Necessary entries regarding Interest Free Medical Advance will be made in the Service Book of the loanee with amount, number and date of Government Order, Contingent Bill number


and date of drawal of the loan. Date of encashment is to be intimated. In case of Non drawal/cancellation of Interest Free Medical Advance, the said fact will be reported to Government without fail. The unutilized amount if any should be refunded immediately.
