ORDER

Smt. Darley. D.S. Mony, Senior Town Planner working in the office of the Chief Town Planner aggrieved by the orders issued transferring her to the office of Regional Chief Town Planner Eranakulam as per the Governmen to Order read as 1st paper above, filed OA No.1347/2013 before the Kerala Administrative Tribunal. The Hon'ble Tribunal in the Order dated 1.8.2013 directed the Chief Town Planner (2nd Respondent) to forward the representation filed by Smt. Darley. D.S. Mony(Annexure A3) along with his comments to the Government (1strespondent) within two weeks from the date of receipt of a copy of this order. Upon receipt of the same, the first respondent shall consider and pass orders on it in accordance with law after affording an opportunity of being heard to the applicant and Sri. K.Remanan, Senior Town Planner (3rd respondent), within two months from the date of receipt of it. The Tribunal also ordered that the interim order granted by the Tribunal to retain the applicant at Thiruvananthapuram will remain in force till the first respondent takes a decision as directed above.

The applicant and 3rd respondent were heard by the Government representative on 7.10.2013.

Government have examined the merits of the case in detail. As per the Geovernment order read as 1st paper above Smt. Darley. D.S. Mony, Senior Town Planner working in the office of the Chief Town Planner and Sri. K.Remanan, Senior Town Planner working in the Office of Regional Town Planning Office Eranakulam were mutually transferred. In the appeal

preferred by Smt. Darley.D.S. Money she contended that she has a few years of service left with and due to her personal inconvenience, she requested that the orders issued transferring her to Eranakulam be reviewed.

Transfer and postings of Town Planners and Senior Town Planners ordered under the GO read above were as a part of General Transfer and also on Public interest. The petitioner Smt.Darley D.S. Mony has been working in Thiruvananthapuram District for the last 15 years ie. from 1998 onwards. She is only 53 years and is left with a service of 3 more years. Shri. K. Ramanan, Senior Town Planner who has been transferred from RTP office, Ernakulam has already completed 4 years in that station. Mutual transfer of these officers ordered as per the Government Order read as 1st paper above does not violate any of the norms regarding transfer of officers. Moreover along with Annexure A3 representation the petitioner has not produced any satisfactory evidence to prove her claims. Hence, the request contained in Annexure A3 has no merit for consideration. Hence the request is rejected with direction to the incumbents to join duty forthwith, in the respective stations to which they are transferred. The order of the Kerala Administrative Tribunal read as 2nd paper above is thus complied with.
