O R D E R

As per G.O. read as 1st paper above, Government had approved and adopted the Standard Bidding Document for construction and maintenance of PMGSY roads in the State and section 4.24 of the Standard Bidding Document provides for Dispute Redressal System.

2. Member Secretary, KSRRDA vide letter read above has informed that Package No.KR-13-30 in Pazhayannur Block, Thrissur was entrusted with Sri.Roy Mathew, Contractor for execution. During execution certain disputes arose between the contractor and the Department. He placed certain matters of dispute before the Superintending Engineer/Competent Authority under clause 24.1 of the Standard Bidding Document. The Competent Authority had heard his grievances and has disposed the same. However, the contractor, has submitted his appeal filed against the order No.689/2012KSRRDA dated 21.03.2013. Sri.Roy Mathew, in his appeal dated 20.07.2013, has requested to constitute the Standing Empowered Committee. Member Secretary, Kerala State Rural Roads Development Agency has

requested to constitute the Empowered Committee with the following combination.

- i. One official member, Chairman of the Standing Empowered Committee, not below the rank of Additional Secretary to the State Government.
- ii. One official member not below the rank of Chief Engineer; and
- iii. One non official member who will be technical expert of Chief Engineer's level selected by the contractor from a panel three persons given to him by the employer.

3. In the circumstances Government are pleased to constitute the Empowered Standing Committee with the following member for the purpose of section 4.24.3 of the Standard Bidding Document.

- (i) Principal Secretary, LSGD - Chairman.
- (ii) Sri.P.R.Sajikumar, Chief Engineer, LSGD - Official Member.
- (iii) Sri.R.Murukeshan, Chief Engineer (Rtd) - Non Official Member
(Member selected by the Contractor)
