O R D E R

In the circumstances reported by the Commissioner for Rural Development in his letter read as 3rd paper above ex-post facto sanction is accorded to the Project Directors, Poverty Alleviation Unit of the participating District Panchayats to provide assistance to the beneficiaries deputed to Regional SARAS at Pragathimaidan, New Delhi from 14/11/2013 to 27/11/2013 subject to the following terms and conditions:

- (i) Each beneficiary will be paid to and fro Travel Expenses limited to Sleeper Class rail fare and actual rail freight charges, and porter charges of the products to be brought to the venue at Pragathimaidan, New Delhi.
- (ii) An amount of Rs.200/- (Rupees Two hundred only) will be paid to the beneficiaries for meeting incidental expenses during the to and fro journey.
- (iii) A lumpsum amount of Rs.1000/- (Rupees One thousand only) will be paid to each beneficiaries / representative SHG for meeting the expenses towards incidental expenses and local transport at Pragathimaidan, New Delhi.
- (iv) The expenditure will be met from the budget provision of Rs.10 lakh provided vide G.O. read as 1st paper above. Project Directors will release an advance of Rs.2000/- (Rupees Two thousand only) each

to the participant, subject to final adjustment on production of certificate of participation from Ministry of Rural Development / Charge Officers of the State.

- (v) The beneficiaries will be solely responsible for the transportation and sale of products at Pragathimaidan, New Delhi. The Poverty Alleviation Units or State Government will not be responsible for any loss sustained to the artisan during the journey or at the fair.

Expost facto sanction is also accorded to meet the T.A./D.A. and other expenses of the officer, Shri.V.K.Vijayan, Assistant Development Commissioner who was deputed as State Co-ordinator to the Regional SARAS Fair held at Pragathimaidan, New Delhi from the DRDA Administration fund.
