## ORDER

He has also requested Government to issue orders transferring all documents regarding the landed properties which were under the ownership of Kerala State Rural Development Board and taken by the Government and kept under the custody of Special Officer, KSRDB as directed by the Government to Kerala Urban and Rural Development Finance Corporation Ltd. •
- **3.** Government have examined the matter in detail and are pleased to accord sanction to the Special Officer, KSRDB to transfer the 45 cents of land at Kasaba Village in survey No. 509/04 in Kozhikkode District which is owned by the Government as per the G.O. Read as 1st paper above to KURDFC and to transfer all the documents regarding the landed properties which were under the ownership of KSRDB and taken by the Government and kept under the custody of Special Officer, Kerala State Rural Development Board to Kerala Urban and Rural Development Finance Corporation Ltd. The Managing Director, KURDFC is authorised to receive the documents in relation to KSRDBfrom the Special Officer, KSRDB and to make necessary arrangements including the registration etc.for keeping it

in the custody of Kerala Urban and Rural Development Finance Corporation Ltd.
