O R D E R

Government of India had published the Amendment to the Schedule I & II in the MGNREGS Act. The amended provision should come into force on the date of its publication in the Official Gazette (03.01.2014). Since the amendment to the schedule proposes fundamental changes in the minimum features of the scheme and the conditions for the guaranteed rural employment under the scheme and entitlements of labourers, the Mahatma Gandhi National Rural Employment Guarantee Scheme of Kerala (Issued as per GO(MS)144/2006 dated 23.06.2006 notified in the Gazette as 1052/2006) requires revision accordance with the Revised Schedules. Government of India instructed all states to amend their respective State Schemes.

Hence, the Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme as per the letter read above had suggested to constitute a committee as suggested below to revise State Scheme in accordance with the New Amendments in the Schedule I & II.

The committee should submit the draft proposal to Government within a period of 3 weeks from the date of its constitution.


