The Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme had requested to accord sanction for the deputation of these officers to National Institute of Rural Development, Hyderabad for the Training of Trainers Programme from 27th to 29th of November, 2013. It is also requested permission for the air journey of officer from Sl.No.13 to 16 since they are not eligible for air journey (Shri.Ajith.U., District Level IT Professional, Wayanad who traveled from Kozhikode to Hyderabad performed return journey by road) and permission to meet the air travel expenses of Sri.C.B.Mohanadasan (SQM, MGNREGS) who is a retired Joint Development Commissioner from the administrative cost of the Mahatma Gandhi National Rural Employment Guarantee Scheme State Cell.

Government have examined the matters in detail. In the circumstances reported by the Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme, ex post facto sanction is accorded for the deputation of the State Resources Team for attending the Training of Trainees at NIRD, Hyderabad from 27th to 29th November, 2013 and special sanction is accorded for the deputation of the officers from Serial No.13 to 16 to Hyderabad by air. Expenses in

this regard should be met from the Administrative cost of Mahatma Gandhi National Rural Employment Guarantee Scheme, and Special sanction is also be accorded for meeting the expenses of Shri.C.B.Mohanadasan, State Quality Monitor from the administrative cost of MGNREGA State Cell, since he is a retired Joint Development Commissioner and not eligible for TA/DA as a special case.
