## <u>ORDER</u>

Sri.Santhosh.K, S/o.Late Sasidharan.K, formerly Peon, Block Development Office, Kozhikode, residing at Kidangath House, Paringattuparamba, P.O.Beypore, Kozhikode -15, as per his application read as 3<sup>rd</sup> paper above has applied for employment assistance under Compassionate Employment Scheme. The matter was enquired through the District Collector, Kozhikode and has recommended the request for employment assistance as per the report read as 4<sup>th</sup> paper above.

Sri.Sasidharan.K. expired on 08.06.2007 while working as Peon, Block Development Office, Kozhikode in the Rural Development Department. He had put in a total service of 29 years, 6months & 4 days at the time of his death. His son Sri.Santhosh.K. has applied for employment assistance under the scheme. All other dependents have relinquished their claim for employment assistance in favour of the applicant.

As per the Government Order read as 1st paper above, the time limit for preferring applications under the scheme will be 2 years from the date of death of Government Servants. But Sri.Santhosh.K. submitted his application on 24.08.2009. The Commissioner for Rural Development have recommended the applicant for appointment under the Scheme as Office Attendant in the Rural Development Department in Kozhikode District in relaxation to the condition specified in the Government Order read as 1st paper above. Sri.Santhosh.K. had Completed 8th Standard. He is aged 36 years. His date of birth is 15.01.1978. His annual family income is Rs.64,884/-. He has requested for appointment as Office Attendant in Rural Development Department in Kozhikode District. The applicant satisfies all the conditions for being appointed as Office Attendant.

In the circumstances reported by the District Collector, Kozhikode and the Commissioner for Rural Development, Thiruvananthapuram in the letters read as 4th and 5th paper above, sanction is accorded for the appointment of Sri.Santhosh.K, S/o.Late Sasidharan.K, formerly Peon, Block Development Office, Kozhikode, residing at Kidangath House, Paringattuparamba, P.O.Beypore, Kozhikode -15 under compassionate employment scheme in the existing/ arising vacancy of Office Attendant in the Rural Development Department in Kozhikode District in relaxation to the provisions contained in the Government Order read as 1st paper above, subject to the provisions governing the scheme. The Commissioner for Rural Development will issue formal posting orders to the applicant.

Sri.Santhosh.K. will produce a copy of his photograph, recently taken, duly attested by a Gazetted Officer before the Commissioner for Rural Development at the time of joining duty. Before admitting him to duty, the original documents in proof of his age, educational qualification and medical fitness should be verified. His character and antecedents will also be got verified through the Police Department in due course. If the appointment is in a District other than the District of option for want of vacancy, he will be given transfer to the District of option in the next arising vacancy without loss of seniority. The five year rule prescribed for inter-district transfer of district-wise recruits will be made applicable in this case from the date of posting to the district of his choice. The details of appointment under the scheme will be entered in the Service Book of the deceased Government employee and also in the Establishment Register of the office in which the Government employee last worked and the fact will be attested by Head of office/Head of Department.

The appointment will be cancelled if and when it is found that there was misrepresentation or suppression of material facts at the time of applying for appointment under the Compassionate Employment Scheme or during the course of the enquiry by the departmental authorities.

Government will have the right to cancel the order sanctioning this appointment under the Compassionate Employment Scheme if, after the issue of the order, it is seen on examination that the orders were issued erroneously.
