ORDER

Sri.K.Sureshkumar, Village Extension Officer (Housing), Block Development Office, Mavelikara filed O.A.No.312/2014 before the Hon'ble Kerala Administrative Tribunal praying to give directions to Government to consider his representation (Annexure A9) read as 3rd paper above and to pass orders to set aside the orders read as 1st paper above and to grant him posting to the stations opted by him in his representation (Thiruvananthapuram) to look after his son aged 13 suffering from "Attention Deficit Hyper activity. Disorder" as parents of such disabled children are entitled to get preference in the matter of transfer as per transfer norms.

The Hon'ble Kerala Administrative Tribunal, in its order read as 3rd paper above directed the first respondent ie, Principal Secretary, Local Self Government Department to consider and pass orders on Annexure A9 representation read as 2nd paper above in accordance with law, after affording an opportunity of being heard to the applicant and respondents 4 to 7 within two months from the date of receipt of a copy of the order.

As per the direction of the Hon'ble Kerala Administrative Tribunal the petitioner and the respondents 4 to 7 were heard on 12.05.2014. The only

request of the petitioner was that to give him a transfer to a suitable place in Thiruvananthapuram District to look after his ailing son.

The representative of the Commissioner for Rural Development has informed that the Annexure A9 representation submitted by the petitioner would be considered favourably on the basis of the existing guidelines for transfer of Government employees and transfer would be effected during the General Transfer of General Extension Officers/Extension Officers during May 2014. The Commissioner for Rural Development will strictly comply with the promise put forth by him during hearing. Thus the orders of the Hon'ble Kerala Administrative Tribunal is complied with.
