ORDER

Shri. S Sunny, daily waged part time sweeper in Poverty Alleviation Unit, Kollam had filed writ petition before the Hon'ble High Court of Kerala for regularizing his service and to get promotion to the post of peon. The Hon'ble High Court in its judgment as read as 1st paper above, has directed Government to promote the petitioner to the post of peon on the date of entitlement of the promotion and give consequential benefits. Government had filed Writ Appeal against the judgment and the Hon'ble High Court in its judgment read as 2nd paper above has dismissed the Writ Appeal.

Government have examined the matter in detail and are pleased to accord sanction to the Commissioner for Rural Development to regularize the service of Shri S Sunny as Part Time Sweeper in Poverty Alleviation Unit, Kollam with effect from 09.11.1995 (only provisional promotion to be given him in the category of Part Time Sweeper with effect from 09.11.1995) and to give him higher ladder promotion as Peon, as ordered in the judgment read as 1st paper above.

The judgment of the Hon'ble High Court read as 1st paper above is thus complied with.
