### ORDER

Smt.Beema.F, Extension Officer (Planning & Monitoring), Block Development Office, Chirayinkeezhu, in her application read as 4<sup>th</sup> paper above has requested Government to sanction an amount of Rs.1,20,000/- (Rupees One Lakh Twenty Thousand only) as Interest Free Medical Advance for her treatment at Regional Cancer Centre, Thiruvananthapuram. The Commissioner for Rural Development has also recommended the application of Smt.Beema.F. as per the letter read as 5<sup>th</sup> paper above.

The Government have examined the matter in detail in the light of the Government Orders read above and are pleased to accord sanction to an amount of Rs.1,00,000/- (Rupees One Lakh only) as Interest Free Medical Advance to Smt.Beema.F, Extension Officer (Planning & Monitoring), Block Development Office, Chirayinkeezhu for her treatment at Regional Cancer Centre, Thiruvananthapuram by debiting the expenditure "7610-00-800-95(02) IFMA to Non Gazetted Officers" in the current year's Budget (2014-15) subject to the conditions specified in the Government Orders read above. The Utilisation Certificate duly countersigned by the Medical Officer of the Institution should be produced within 3 months from the date of drawal and the advance should be settled within 6 months. In case of default, penal interest @ 12% will be charged. Necessary entries regarding Interest Free Medical Advance will be made in the Service Book of the loanee with amount, number and date of Government Order, Contingent Bill number and date of drawal of the loan. Date of encashment is to be intimated. In case of Non drawal/cancellation of Interest Free Medical Advance, the said fact will be

reported to Government without fail. The unutilized amount if any should be refunded immediately.
