### **ORDER**

1. The 4<sup>th</sup> instalment of the General Purpose Fund (GPF) for the year 2014-15 to the Local Self Government institutions (LSGIs) after various financial adjustments already in position, is sanctioned by the Finance Department vide order read as 3<sup>rd</sup> paper above.


