- 3. Store Purchase Rules shall be strictly adhered to.
- 4. Tender / e-tender and other stipulated formalities shall be followed wherever necessary.
- 5. For Civil Works Central Public Work Department rates shall be followed.
- 6. Post Creation and Purchase of vehicles are not admissible under the scheme (s).

  KILA will be the implementing agency & monitoring mechanism of the scheme.
