The Commissioner for Rural Development as per the letter read as 4th paper above has informed that the Rural Development Department is proposed to organize trade fair in all district except in Wayanad, Idukki, Thrissur from 01.09.2014 to 05.09.2014 by meeting the expenses from SGSY fund with Poverty Alleviation Unit amounting to Rs.39,79,432/- for 12 districts as given in annexure. As per the proceedings of Commissioner for Rural Development read as 3rd paper above an amount of Rs.10 lakhs was sanctioned for granting assistance for the district level marketing outlet of rural product in which organizing trade fair for rural products at district level. Hence Commissioner has

requested for sanction to meet Rs.6 lakhs (Rupees Six lakhs only) from Rs.10 lakhs sanctioned under the Head of Account 2515-00-102-41 (02)

Government have examined the case in details and are pleased to accord sanction to meet Rs.39,79,432 (Rupees Thirty Nine Lakh Seventy Nine Thousand Four Hundred and Thirty Two) from the unutilized SGSY fund kept with Poverty Alleviation Units as detailed in annexure given and also to expend Rs.6 lakhs from the Head of Account 2515-00-102-41(02) for the conduct of IRDP SGSY trade fair from 01.09.2014 to 05.09.2014.
