ORDER

Smt.S.Jayalekshmi, Village Extension Officer Grade I, Block Development Office, Sasthamkotta, Kollam in her application read as 4th paper above has requested Government to sanction an amount of Rs.1,20,000/- (Rupees One Lakh Twenty thousand Only) as Interest Free Medical Advance for her cancer treatment at Lakeshore Hospital, Kochi. The Commissioner for Rural Development has also recommended the application of Smt.Jayalekshmi vide letter read as 5th paper above.

Government have examined the matter in detail in the light of the Government Orders read above and are pleased to accord sanction to an amount of Rs.75,000/- (Rupees Seventy Five Thousand only) as Interest Free Medical Advance to Smt. S.Jayalekshmi, Village Extension Officer Grade I, Block Development Office, Sasthamkotta, Kollam for her cancer treatment at Lakeshore Hospital, Kochi by debiting the expenditure under the head of account "7610-00-800-95(02) IFMA to Non Gazetted Officers" in the current year's Budget, subject to the conditions specified in the Government Orders read above. The Utilization Certificate duly countersigned by the Medical Officer of the Institution should be produced within 3 months from the date of drawal and the advance should be settled within 6 months. In case of default, penal interest @ 12% will be charged. Necessary entries regarding Interest Free Medical Advance will be made in the Service Book of the loanee with amount, number and date of Government Order, Contingent Bill number and date of drawal of the

loan. Date of encashment is to be intimated. In case of Non drawal/cancellation of Interest Free Medical Advance, the said fact will be reported to Government without fail. The unutilized amount if any should be refunded immediately.
