ORDER

As per the Judgment read as 1st paper above, the Hon'ble High Court has directed the 1st respondent (Government) to pass final orders on the application of the petitioner for regularization of the building within a period of 2 months. To facilitate an early action, the petitioner shall be at liberty to produce a copy of the writ petition together with a copy of this judgment before the 1st respondent (Government) within a period of one month.

As directed in the judgment, the Petitioner submitted application for occupancy to Government on 27.08.2014. As per the letter read as 2nd paper above, the Secretary, Thrissur Corporation has informed the Government that the rule violations are rectified by the Petitioner and requested to grant permission for giving occupancy certificate to the Petitioner. In this regard Chief Town Planner (Vigilance) inspected the site and reported that the violations are

rectified and recommended the Government to issue direction to the Secretary, Thrissur Corporation for giving occupancy certificate to the Petitioner .

Government have examined the matter in detail and are pleased to direct the Secretary, Thrissur Corporation to grant occupancy certificate to the commercial building constructed by the Petitioner in Sy No.887/2 of Ayyanthole Village in Thrissur Corporation.

The directions contained in the judgment are thus complied with.


